Mass Meeting

Lee County Republican Committee
of the Republican Party of Virginia

As Chairman of the Lee County Republican Committee, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Cody Bach, do hereby issue this call for a Mass Meeting to be held at Lee High School CB Slemp Auditorium-Music Building, 200 General Lane Jonesville, Virginia 24263, starting at 12:00 P.M. local time (with registration opening at 9:00 A.M. thru 11:00 A.M. on June 3rd, 2023 for the following purposes:

Nominating Candidates for the 2023 Lee County Local Election.

1. Nominating a Republican candidate for (Circuit Court Clerk, Commissioner of Revenue, Commonwealth Attorney, Sheriff, Treasurer) and for Board of Supervisors for the (DISTRICTS 1-5). to be voted upon in the November 7, 2023 General Election;
2. And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of Lee County under the laws of the Commonwealth of Virginia (**Valid Photo ID is Required**), regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years.

A single exception to this shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of this writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the forgoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception thereafter.

Filing Requirements

Candidates for election for Circuit Court Clerk, Commissioner of Revenue, Commonwealth Attorney, Sheriff, Treasurer) and for Board of Supervisors for the (DISTRICTS 1-5) at said mass meeting shall file a written statement by mail or in person, to Lee County Republican Committee P.O. Box 101 Jonesville, Virginia 24263, which must be received not later than [6:30 P.M. April 20, 2023] and accompanied by any fees required. Postmarks shall not govern. (Only NON-Filed **uncontested** Offices can be filed up to June 3rd, 2023.)
